

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
Institut Français d'Indonésie  
AND  
IAIN Sultan Thaha Saifuddin (IAIN STS JAMBI)**

This Memorandum of Understanding, hereinafter referred to as "MOU", supports the development of the cooperation between:

1. **Institut Français d'Indonésie**, hereinafter referred to as IFI, is the division of the French Embassy in Indonesia in charge of implementing academic, scientific, linguistic and cultural cooperation, located on Jl. M.H. Thamrin No.20, RT.9/RW.4, Gondangdia, Menteng, Kota Jakarta Pusat, Daerah Khusus Ibukota Jakarta. IFI is represented in this matter by **Mr. Marc Piton, Counselor for Cooperation and Culture, Director of IFI**, acting for and behalf of IFI;
2. **IAIN Sultan Thaha Saifuddin (IAIN STS JAMBI)**, hereinafter referred to as "IAIN STS JAMBI", an institution established under the laws of the Republic of Indonesia, located on JL. Jambi-MA. Bulian, KM 16 Sei. Duren Kec. Jaluko, Kab. Muara Jambi – 36363, Kota Jambi, Jambi. IAIN STS JAMBI is represented in this matter by **Dr. H. Hadri Hasan, M.A., Rector of IAIN Sultan Thaha Saifuddin, Jambi**, acting and on behalf of IAIN STS JAMBI;

IFI and IAIN STS JAMBI are hereinafter referred to as "the Parties".

**WHERE**

- A. IFI is the division of the French Embassy in Indonesia in charge of implementing academic, scientific, linguistic and cultural cooperation, including French language programs, and strives to strengthen the cooperation with higher education institutions in Indonesia through the IFI network, including Alliance Française Medan.
- B. IAIN STS JAMBI is an established State Institute in Jambi, Indonesia, which strives to strengthen its academic excellence through various collaborations with other parties and institutions.
- C. The Parties wish to enter into this MOU to declare their respective intentions and establish a basis for cooperation and collaboration between the Parties under the terms and conditions set forth below.

**ARTICLE 5 - ENTRY INTO EFFECT, DURATION AND TERMINATION**

1. This MOU will come into effect on the date of signing and will remain in the effect for a period of five years.
2. This MOU may be extended by through both Parties' agreement in writing.
3. Each Party may terminate this MOU by giving the other Party a six (6) month prior written notice.

**ARTICLE 6- COMMUNICATIONS**

All communications related to the implementation of this MoU must be done in writing and in English, and sent via registered mail, electronic mail or facsimile to the addresses provided by both Parties. These addresses may be modified by written notification to the Parties.
